Executive Summary

Each year NASWA conducts a survey of states to gather the latest data on obligations and expenditures for Workforce Investment Act (WIA) funding. The data, also reported to the U.S. Department of Labor (USDOL) on a quarterly basis, allow NASWA to provide timely analysis to Congressional staff during budget deliberations.

For this survey, 47 states, in addition to the District of Columbia (DC), representing over 93 percent of total appropriations (PY 2009, PY 2010, and PY 2011) responded providing data for the respective Program Years.

The results of the survey show that states are spending their WIA funds well within the time constraints imposed by federal law on the allocations. By the end of PY 2011 (June 30, 2012), states that completed the survey had spent virtually all funds allocated in PY 2009 and almost 96 percent of funds allocated for PY 2010.

At the end of PY 2011 (June 30, 2012), states had roughly \$583.9 million in “unobligated/unspent” funds from PY 2010 (\$98.6 million) and PY 2011 (\$485.4 million) to carry into PY 2012 or about 10 percent of the total amount allocated. A very small amount of PY 2009 funds unspent (\$2.05 million or about 0.1 percent) lapsed. See Table 1 for Summary Results.


The survey also sought to determine the extent to which state set-aside funds had been spent and to what extent the funds were used on programs or administration. Data were compiled for each year with the set-aside of 15 percent in PY 2009 and PY 2010, and five percent in PY 2011. The results show most states have exhausted or will shortly spend all of their current five percent set-aside funds. The NASWA analysis also shows the available carryover for the PY 2010 and PY 2011 state set-aside funds was \$92 million or 17.3 percent of appropriated funds as of June 30, 2011. In the past, USDOL financial reports have often suggested a much slower pace of spending as USDOL reports did not adjust for unliquidated obligations when showing “funds available (carry forward)” to the states. These funds (unliquidated obligations) are legally binding commitments made by states and for which an accrued expenditure has not yet been booked. They are not “available” for new commitments. These and other terms are defined in [**Training and Employment Guidance Letter \(TEGL\) 28-10.**](#)



In short, USDOL generally recognizes only expenditures to gauge available funds, therefore overestimating what states actually have for future spending. Further, much of the remaining unobligated/unspent funds going into PY 2012 are for future expenses such as leases, long term training, or salaries, which cannot be booked as obligations until they are due. These reporting issues have created misunderstanding and confusion among states, USDOL, and Congressional staff on the House and Senate Committees on Appropriations. The issue carries adverse implications as Congress is under the false impression states are not spending their formula funds in a timely manner. This has led to unjustifiable rescissions in the past and over the last two years funding cuts to the workforce system.

Reduction in the WIA State Set-aside

Under the Full-Year [Continuing Appropriations Act of 2011 \(P.L. 111-10\)](#), Congress, with the support of the USDOL, reduced the 15 percent set-aside for states by 10 percentage points under the WIA and reallocated funds to the Administration’s Workforce Innovation Fund (WIF) and to Local Areas. Consequently, the state set-aside was reduced from a level of approximately \$399 million in PY 2009 to \$133 million for PYs 2011 and 2012. In addition, USDOL’s WIF was reduced from \$125 million to \$50 million as part of the FY 2012 appropriations bill.

This issue does not involve new federal spending. Rather, it is a [reallocation](#) of state grants to the Secretary of Labor in an effort to create competitive grants to be awarded by the Secretary for innovative workforce activities. NASWA is strongly opposed to the grant program.

State and Local Spending Rates

During the course of a given year the spending rate for States and Locals can vary due to a number of factors. The following differences between states and localities help explain why states justifiably carryover funds at a higher rate than localities:

- 1) Many states save state funds for specific projects and large ticket infrastructure costs for the entire workforce system – and these costs may need to be reserved for more than a one-year period.
- 2) States are reserving some funds in anticipation of dealing with a possible sequestration or other budget cuts.
- 3) States have three years to spend WIA funds – localities only have two years.
- 4) In many cases, state staff may charge time to several grants at one time – and may not be tied to one specific grant – like the case managers at the local areas, and
- 5) Unlike many states, localities sub-grant funds, thereby quickly obligating the funds to another entity.

The relative spending rates for states and locals are shown in the Table below:

Survey Design

For the 2012 survey NASWA used the template from prior surveys but added an additional field. The field, line 10f (Total Administrative Expenditures) from the ETA 9130, allowed NASWA to determine how much of the state set aside was expended on programs and how much on administration. The set aside tables that follow in this report show estimates of how much of the set aside was expended on each category.

Forty-seven of the 50 States and DC reported; only three states and a territory did not report.
