





Governor Steve Bullock has proclaimed November 12th-18th Montana Apprenticeship Week. I am excited to celebrate the men and women across the state who use work-based learning to put food on the table, support their families and grow their local economies

Montana's economy continues to thrive with more people working than ever before, an unemployment rate below the national average, and Montana leads the nation in manufacturing GDP growth. It is a good time to be a member of the Treasure State workforce, and apprenticeships are a cornerstone for this success.

As the state's workforce continues to age into retirement, it is critical we look at all opportunities to train our next generation of workers. Since 2013, apprenticeships launched through the Montana Registered Apprenticeship program have increased by almost 50 percent with more signing up each week.

Established in 1941 and administered by the Montana Department of Labor & Industry, Montana's Registered Apprenticeship program has collaborated with businesses, unions and other interested parties to implement customized training curriculum to let workers earn while they learn the skills needed to succeed in their chosen occupation.

Since 2000, the Montana Registered Apprenticeship program has overseen over 7,600 apprenticeships all across Montana. Apprentices who successfully completed their program earned average wages of \$60,754 in 2016. On average, apprentices complete their programs in 43 months. In fact, the carpenter building your house or the medical technician your temperature at the doctor's office may be a former apprentice. We have also added 23 new occupations to the apprenticeship program in the last five years, now offering training in new in-demand occupations like nursing, childcare, and computer science, in addition to the traditional fields.

For people looking at apprenticeships for their career pathway, there are many reasons to pursue this option further:

- Earning an industry-recognized credential from the Montana Department of Labor & Industry,
- Significantly reduced education costs,
- Bringing home a paycheck while learning your occupational skills.

For businesses looking at options to address their industry sector workforce shortages:

- Apprenticeships offer advantages to train employees with the hard (technical, work-based) and soft (customer relations and business culture) skills needed for their organizations. Delete (?)

- Investment in training increases employee loyalty and long-term employment.

The Montana Department of Labor & Industry is committed to building our state's workforce equipped with the tools to succeed in the 21st Century economy. Montana apprentices and businesses deserve the best work-based learning opportunities to ensure our economy can continue to grow. We look forward to continue serving, supporting, and collaborating with the private sector to meet the needs of the Montana workforce.
