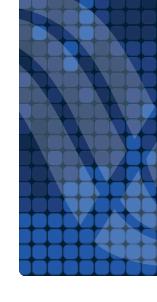
STATE WORKFORCE CIOS 2025-2026 TOP PRIORITIES & INITIATIVES

Priorities for Strategy, Policy, and Management Processes

Each year, State Workforce Agency CIOs participate in a survey to identify their top priorities and initiatives for the coming year. For 2025-2026, budget and fiscal management emerged as the number one priority due to funding cuts impacting state operations. Cybersecurity remains a critical concern, maintaining its place among the top priorities. Artificial Intelligence continues to gain momentum, sustaining its high ranking as states explore its transformative potential in workforce development. Digital government has dropped in priority this year to #8, reflecting a shift toward more urgent operational needs like budget and modernization.
